ADDITIONAL RULES OF ENTRY

- Exhibitors in this Department must be aged 62 or older as of January 1st of the fair year.
- Exhibitors in this Department must be an Oconto County Resident.
- All exhibits must have been created by the exhibitor.
- Only one exhibit may be entered under each lot number.

CLASS A – HONEY

REQUIREMENTS:

- Honey and beeswax products must be the product of bees owned by the exhibitor
- Honey must be in a certified glass container with ring
- Honey entries may be opened by the judge

Lot Numbers:

1. Beeswax and beeswax products
2. Honey, any type, 1 pint

CLASS B - MAPLE SYRUP

REQUIREMENTS:

- Maple syrup must be from the current season's crop
- Maple syrup must be in a certified glass container with ring
- Maple Syrup entries may be opened by the judge
- **Definitions:**
 - 'Commercial' maple syrup is from producers selling syrup commercially
 - 'Non-commercial' maple syrup is from hobby producers who produce syrup for their own use. May have made occasional sales

Lot Numbers:

1. Maple syrup, light 1 pint – non-commercial
2. Maple syrup, dark 1 pint – non-commercial
3. Maple syrup, light 1 pint – commercial
4. Maple syrup, dark 1 pint – commercial
5. Maple Syrup Sugar
6. Maple Sugar Candy

CLASS C - CHRISTMAS TREES

REQUIREMENTS:

- Trees must have been grown in Oconto County
- Trees must be freshly cut
- Trees will be judged based on USDA Christmas Tree Grades
- Trees must be exhibited standing in a pail of moist sand or sand/moss mixture furnished by the exhibitor
- Trees must be between 5 feet and 8 feet tall, measured from the tip of the leader to the bottom of the handle. A trimmed handle shall be no less than 6" long or more than 1 $\frac{3}{4}$ " for each foot of tree height
- Artificially colored trees will be disqualified
- Exhibitors may enter as many lot numbers as they wish but no more than one tree per lot number

Lot Numbers:

1. Norway Pine
2. Balsam, Frasier, or Douglas Fir
3. Norway, Black, Colorado, or White Spruce
4. Scotch Pine
5. White Pine
